2.—The Company will in the meantime pay interest thereon at the rate of six dollars per cent. per annum by equal half-yearly payments on the 30th day of June and the 31st day of December in each year in accordance with the Coupons annexed hereto, the first of such half-yearly payments to be made on the 30th day of June, 1909.

3.—The Company hereby charges with such payments All those pieces or parcels of ground situate lying and being at Victoria in the Colony of Hongkong and registered in the Land Office there as Marine Lot No. 5, Remaining Portion of Marine Lot No. 3, Remaining Portion of Marine Lot No. 7, and Section C of the Praya Reclamation to Marine Lot No. 7, with all erections and buildings for the time being respectively thereon, and the rights, easements, and appurtenances thereto respectively belonging or appertaining.
